OFFICE ORDER

Sub. : Constitution of a Consultative Committee to work out the modalities of coordination and programme implementation for a Slum Free Delhi.

In order to facilitate/bring about effective co-ordination between all the agencies mandated with ensuring planned and orderly urban growth of Delhi, namely, Govt. of NCTD, DDA, MCD, NDMC, DUSIB and NCRPB, with the specific objective of creating an inclusive and slum free city within a time – bound period, it has been decided to constitute a Consultative Committee under the Joint Chairpersonship of Secretary Ministry of Urban Development and Secretary, Ministry of Housing & Poverty Alleviation.



3. The Terms of Reference of the Committee are as under :-

1. To facilitate increased supply of land into the market, by suggesting mechanisms and timelines for implementation of the provisions of MPD – 2021 for reservation of land/FAR for EWS/LIG housing.
 2. To examine & propose mechanisms and timelines for preparation & implementation of zonal/local plans to give effect to the provisions of MPD 2021.
 3. To examine the provisions/norms of the MPD – 2021 which inhibit implementation of slum redevelopment projects, including but not limited to density norms; and to suggest the amendments required.
 4. To examine the process of permission for relaxation in planning norms/building bye-laws for slum re-development/rehabilitation projects; and suggest the measures required to simplify and fast-track approvals.
 5. To suggest mechanisms for convergence and co-ordination between the agencies providing basic civic and social services like electricity, water, housing, roads, solid waste management, street lighting etc.
 6. To recommend modalities for earmarking space for urban poor alongside transport corridors ; and earmarking of spaces for street vending/informal sector
 7. To suggest strategies and models and modifications to the MPD-2021, if necessary, for creation of new Affordable Housing stock with special reference to rental housing.
 8. To ensure co-ordination between all land owning agencies in Delhi for undertaking the slum socio-economic survey and the preparation of Slum Free City Plans.
4. A quarterly meeting shall be taken by the Hon'ble Minister (HUPA&C) to review the progress towards the above objectives .
